VERIFICATION OF 2014 INCOME INFORMATION. In most cases, no further documentation is needed to verify 2014 income information that was transferred into the student's FAFSA using the IRS DRT if that information was not changed. If you are unable to use the Data Retrieval Tool, you may obtain your 2014 IRS Tax Return Transcript online at www.irs.gov/Individuals/Get-Transcript. (typically available 2-3 weeks after filing your tax return.)
